

INQUIRY RULING

APPLICATIONS FOR MEDIA ACCREDITATION

Pursuant to paragraph 3 of the Inquiry Protocol: Media and Conduct in the Inquiry's Hearing Room, and the Inquiry's Ruling dated 14 May 2014, the Panel have now reconsidered the applications received for media accreditation.

As was made clear at the Inquiry's preliminary hearing on the 3 April 2014, the only benefit of accreditations relate to use of the media room at the Inquiry's premises at 11 Seaton Place, which is a limited facility that is relatively small. The purpose of the room is to afford journalists with electronic access to be able to file stories promptly. On busy hearing days there has been considerable pressure on space.

Having reconsidered the applications, the Panel grants media accreditation to the following, as they are likely to require the electronic facilities that are provided:

- BBC National
- Jersey Evening Post
- ITV Channel Television
- Channel 103
- BBC Jersey
- Bailiwick Express

Approved representatives from the above organisations will be permitted entry to the media room at Seaton Place and may be asked to present their press card as proof of identity.

There are two ISDN lines in the media room which means that there will be regular live broadcasting from the office. There is also WiFi to allow for the constant updating of news websites, keeping the public informed of the daily developments.

Media accreditation has not been granted to the following:

- Neil McMurray of the blog Voice for Children
- Bob Hill of the blog Jersey Blogspot

as it is not considered that they will require access to the electronic facilities listed. The Inquiry is exploring the provision of WiFi in public areas.

Due to space constraints, those who have not been granted media accreditation are asked not to enter the media room at Seaton Place; they will be able to cover hearings every day in the Hearing Room (subject to available space). Access to the transcripts and supporting documents will be available from the Inquiry's website.

Independent Jersey Care Inquiry

People who attend the public hearings are also requested to turn off, and not to use, any equipment such as phones, laptops or tablet computers from the hearing chamber. This avoids the risk of witnesses being photographed whilst giving evidence. We are also keen to avoid the public dissemination of names that are mistakenly mentioned in evidence in the chamber.

The media are reminded that any breaches of media protocol could result in accreditation being withdrawn. The media are reminded that witnesses are not to be approached for interviews whilst in the vicinity of the Inquiry. Attention is drawn specifically in paragraph 12 of our media protocol published on our website.

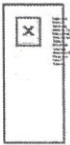

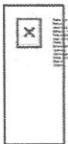

Dear Anna,

Just a note following my reading of the media guidelines listed on the Enquiry website.

We, like other national media organisations, are grateful for the fact that the enquiry team have made provision for accredited journalists to attend the hearings, but I am concerned at the conditions that you attach to accreditation in Jersey.

At this stage, I would like to request two seats for BBC National TV and Radio, but I need to stress that our presence is likely to be occasional, and confined to what we see as key days.

On that basis, it's impossible to inform you as to the names of those journalists assigned or to provide you with photos as requested. Although it's likely that I will attend when available, or my colleague Duncan Kennedy, based out of Southampton, that is not a given, if those key dates coincide with other stories.

Decisions may be taken as late as the previous day; we will of course let the enquiry know as far in advance as possible should programmes ask for coverage. That applies to both TV (and Radio.

The likelihood is that one journalist, with producer backup will cover all BBC National outlets, including online output.

We will of course also be working closely with our colleagues in the Channel Islands, and I am in constant touch with Jon Gripton in Jersey.

I do hope that you can accommodate our difficulties; having been involved with these issues since 2008, I know the importance of covering the enquiry as it progresses.

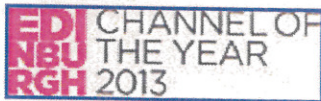
